MSRDC - Film Shooting Terms and Conditions

- 1. This permission is granted on Bandra-Worli Sea Link Road only.
- 2. It is mandatory to display MSRDC logo.
- 3. You will organize your activities in such a way that there is no obstruction to tolling or any activities of MSRDC in respect of toll collection / MSRDC activities so as not to block any traffic or create any obstruction for free movement of other vehicles on the bridge / road.
- 4. The MSRDC shall not be responsible or liable for any monetary claim or otherwise in case any accident or any other event that takes place during the said activity.
- 5. The said activity should not send any message which is against observance of discipline on the road/bridge and against traffic rules and regulations.
- 6. No commercial use including but not limited to video recording, photographs archiving of the event, shall be permitted before, during or after putting up the illumination or any such commercial advantage that could be produced out of such advertisement.
- 7. You will abide by all instructions of the representatives of the MSRDC accompanying your group to avoid accidents and obstructions to moving traffic.
- 8. Minimum number of vehicles shall be used for the said activity and traffic movement shall not be obstructed.
- 9. You will be wholly and exclusively responsible to obtain prior permissions, if required under any law for conducting said activity in public place.
- 10. No arms or explosives shall be used during said activity without obtaining permission under the law.
- 11. Distribution of the schedule of common wealth games at toll plaza shall not be allowed.
- 12. No defacement or damage shall be caused to any MSRDC property. You will indemnify MSRDC and keep it indemnified against any loss or defacement or damage that may be suffered by MSRDC as a consequence, directly or indirectly, during the course & activity. Towards the discharge of this liability, you will deposit with MSRDC a sum of Rs.1,00,000/- (Rupees One Lakh only) towards refundable security deposit by D/D payable to the 'MSRDC, Ltd.' payable @ Mumbai which will be appropriated against the amount of loss or damage suffered by MSRDC but without prejudice to its right to claim further loss or damage, if any. If there is no damage or loss suffered by MSRDC, the sum deposited by you will be refunded within Thirty days without interest after receiving a request from you.

- 13. The charges as leviable are waived subject to Board of Directors' approval and its decision in this regard shall be final and shall have to be accepted by you. Applicable taxes will be deducted from refundable deposit.
- 14. The electricity Charges during the Camping shall be borne by the organizer.
- 15. The permission is given only for public purpose and public awareness for Games, as mentioned in the application.
- 16. There shall no case precedence of this permission for any of such or similar event for similar or such propose on similar or such occasions.
- 17. This permission shall be in compliance of and subject to any or all such terms & conditions including payment of deposit / fees for such events as laid down by MSRDC.
- 18. The party shall provide necessary traffic cones and shall provide minimum two persons wearing reflective jackets with red flag of size 1 m x 1 m in their hand 100 m before the place of the said activity wearing reflective jackets as a traffic safety and regulation measure. Sufficient number of cones shall be provided in the area of said activity.
- 19. Necessary NOC from Police, Traffic Police and MMB shall be obtained in advance and copies thereof shall be submitted to MSRDC before the event starts. Conditions, if any, laid down by these authorities shall be strictly complied.
- 20. It should be ensured that no inconvenience or nuisance of any nature on any account is caused to the residents of the nearby area. It should also be ensured that the residents in the nearby area have no cause of any complaints due to the said activity.
- 21. Use of loud speakers or any other equipment's / vehicles / crackers / explosives / generators etc. producing high noise levels shall be used only in accordance with the prevailing law and rules imposed by the concerned authorities such as Police / MCGM etc. Strict compliance of the rules is necessary. Reflectors / bright spotlights shall not be used after 9:00 PM. In any case care should be taken to ensure that road traffic is not at all affected due to light used for the said activity.
- 22. The activity will have to be stopped immediately in case any complaint is made by the residents regarding any nuisance/ inconvenience caused to them.
- 23. The permission is granted subject to the condition that the activity does not attract any commercial benefit directly or indirectly.
